Save our Parliaments from Archaism creating escalating dictatorships

### **Violent Cavalcade to federal Parliament House August 19, 1996**

A 'Cavalcade' from all States, organised by Greg Combet of the Council of Trade Unions against legislation to abolish compulsory trade union membership, assembled between the New and Old Parliament Houses on August 19, 1996. 20,000 gathered by midday. Luke Deeri analysed what followed in a PhD thesis for the Australian National University. "The planned demonstration went awfully wrong. A minority of protesters from the CEMFU ignored the official rally and separately marched up from Commonwealth Avenue to mount a most forceful attack on the Federal Parliament building itself – the only one so far in history. The Speaker of the House of Representatives, B. Halverson, declared: "The protest had begun peacefully but then, around 12.10 pm, a separate group of CEMFU members, some distance away towards the Parliament House, rejected their designated site where the official speakers were. This group refused to accept police direction, attacked then forced a breach in police lines. Having done so, they then ran towards the main entrance to Parliament House to fight improvised defence lines to break through a successive barrier, using heavy steel weapons to smash the second line into the souvenirs and bookshop leading into the Marble Foyer where security held them at last.

### **Illegal Green Leaders' Inspirational 'Sit-Down' (*The Australian* 3.12.1215)**

"A shut-down of the Parliament House entrance yesterday temporarily blocked paramedical access to a person suffering a heart attack. The 'Peoples Parliament' in the Marble Foyer, supported by Green MP's and active groups, including GetUp! and 350.org, was broken up by police and security guards. Senator di Natale said he was told of the growing protest and went down from the Senate Chamber to lend his support while the Party Co-Deputy 'Greens' Leader, Senator di Natale said he learned of it from Twitter. He declared: 'We have people from right around Australia saying to their governments: "We need a future for our children. We need action on climate change. We need to burn sun and wind to power this economy. This is inspirational. I will take these voices to Paris next week to tell the world that Australia wants action on climate change." The Institute of Public Affairs Director of Energy Policy criticised the failure of authorities to lay charges over the 'sit-down.' "There is one rule for environmental protesters in this country, and another rule for the rest of us. No other group of Australians would be able to occupy the Marble Foyer of the National Parliament House *en masse* for 90 minutes then just be released. Why did the Sergeant of Arms fail to arrest them, or reporters fail to report them in the media?"

**We face decline and death of Parliaments, and civilizations, as we know them, via various revolutionaries, who were bred out of the French Revolution and led to our communist and anarchist problems of the Far Left in democratic politics in the nineteenth century.** Its creator, *Adam Weinsaupt*, was a brilliant graduate from a

Jesuit University in Bavaria, who rejected theological government from Rome in order to free the **world from its hegemony**. He was convinced that the world would profit from overthrow of all government and religious institutions in the world to replace them by a world-wide, yet secret, committee of "intimates". **To achieve this aim he would use Jesuit** methods against Jesuits. Universal happiness, complete and rapid, could be achieved by disappearance of hierarchy, rank and riches. He declared **the human race will become one family world-wide**. On May 1776, he founded the Order of Illuminati with Cagliostro, who was committed to avenge the terrible deaths of the Knights Templar, suppressed by the Pope when they tried to wrest his triple crown from him. He described, in prophetic detail, the decapitation of Louis XV1, an event hardly to be envisaged at the time ( *Peter Tomkins The Magic of Obelisks*).

The French Republic, which promised liberty, equality and fraternity for all, was created by the execution of King Louis 16 in 1793 despite the fact he had agreed to a constitution which limited his powers. It began in a violent bloodbath and a civil war that destroyed its creator, Robespierre and ended when Napoleon, the military commander in Paris, seized power via two corrupt elections before instructing his soldiers to close the parliament down. After crowning himself Emperor, he fought destructive wars across Europe, costing 1,000,000 lives over 15 years.

The Honourable Edmund Burke, a prominent member of the Whig Opposition in the British House of Commons, was one of the first leading political commentators outside France to publicly criticise the infant French Revolution and its possible implications for other countries. In contrast to the welcome given by many British to the events in France of 1789, Burke described France, in September of that year, as a country where the people have thrown off the yoke of laws and morals along with their political servitude. In November, he argued that France was a country undone and irrevocable for a long course of time. "I see many inconveniences, not only for Europe, but to this country in particular, from the total political extinction of a great civilisation in the heart of this our Western system.' On November 1, 1790 he published a major attack on the Revolution and its British supporters in *Reflections on the Revolution in France*.

Burke's essential thesis was that the Revolution was dangerous because it sought to destroy rather than to improve past institutions and traditions. He condemned the barbarous philosophy, which he claimed motivated the revolutionaries: "All the pleasing illusions, which made power gentle, and obedience liberal, are to be dissolved by this new conquering 'empire of light and reason.'" "On this scheme of things a king is but a man." **Burke warned that it would lead to a more violent and autocratic state. The usurpation, which in order to subvert ancient institutions by destroying ancient principles, will hold power by arts similar to those by which it has acquired them.** Plots and assassinations will be anticipated by preventive murder and confiscation. Kings will be tyrants from policy when subjects are rebels from principle. When ancient opinions and rules of life are taken away, the loss cannot possibly be estimated. From that moment we have no compass to govern us." Burke shone a beacon of freedom that still forever shines in the British Commonwealth, a gift for which the President of India, one of its largest members, visited the Queen of the Commonwealth in recent years

## **“Bloodlines of the Illuminati whose power grew after the French Revolution.**

In Peter Tomkins' book '**Bloodlines of the Illuminati**' this controversial author claims that the 'Illuminati' was formed from the descendants of 13 powerful families whose ancestors had close, or distant, ties to the original Bavarian Illuminati of the Middle Ages. According to Fritz Springer, their 13 bloodlines are the Astors, the Bundys, the Collins, the Duponts, the Freemans, the Kennedys, the Li, the Onassis, the Reynolds, the Rockefellers, the Rothschilds, the Russells and van Duykes. The response of David Rockefeller to questioning was frank and open: "For more than a century, ideological extremists at either end of the political spectrum have seized upon well-publicised incidents, such as the attack of Castro on the Rockefeller family, for the inordinate influence we wield over our politics and economic institutions. Some even believe we are part of a secret cabal working against the best interests of the United States, characterising my family and myself as 'internationalists' conspiring around the world to build a more integrated global One World political and economic structure. **If that is so I am proud of it**". There are also exclusive clubs of lesser-known descendants of powerful families, who rose to power as CEO's, intellectuals taking over modern economics such as banking (eg the independent Federal Reserve banks), the oil industry, and the mass media.

## **Control of International bankers in Bavaria and Rome (one view).**

After a short term plan of European rebels to achieve control of the world economy failed, they won control of the International Bankers, and directed the implementation of Karl Marx's Communist Manifesto and its anti-thesis by Karl Ritter in Cologne, Germany, in order to use the difference between the two ideologies to enable them to "divide" larger and larger numbers of the human race into opposing camps and brainwash them into fighting and destroying each other. The planned Illuminati movement against European monarchies **only broke out in the capitals of 3 great monarchies - Paris, Vienna and Berlin** - ending in repression and failure. Centralised power only remained in Germany, Austria and Italy due to the fact their middle class and clergy were terrified of Socialism.

Conservative MP Benjamin Disraeli warned **the British House of Commons on July 14, 1856 of significant change in Europe**: "It is useless to deny that it is important to concede that the whole part of Europe is being covered with railways and roads. Just 8 years before, revolutions had broken out across a Europe brewing trouble to come."

20 years on Disraeli declared: 'Let me impress upon the attention of the House the character of this war between Germany and France (1870). It is no common war, like the war between Prussia and Austria or the Italian war with France, or the Crimean War. **This war represents the German revolution, a greater political event than the French revolution of last century.** What its consequences may be in the future who knows. **There is not a diplomatic tradition, which has not been swept away. We have a new world, a new influences at work, new and unknown objects and dangers to cope with.** We once had discussions in this House about the balance of power. Lord Paterson, a practical man, used to trim the sails of the Ship of State and shape its policy with a view to preserve equilibrium in Europe. What has really come to

pass? **The balance of power has been entirely destroyed, and the country which suffers most from the effect of this great change, is England.**

### **Do Communist Revolutions, that succeed, create unjustified chaos?**

Was the Russian Communist revolution justified? The most viable KGB agent, who ever defected to the West, wrote to the London newspaper *The Independent* on July 21 1998. "Russia under Tsar Nicholas 2, with all the survivors of feudalism, had opposition political parties, independent trade unions, newspapers, a rather radical system of parliamentary parties and a modern legal system. Its agriculture was on the level of the USA with industry rapidly approaching Western European levels. In the U.S.S.R we suffered total tyranny, no political liberties and practically no human rights. Its agriculture was destroyed. Its economy was not viable. The terror against the population reached a scope unknown in human history. No wonder many Russians look back at Tsarist Russia as a paradise lost."

Was World War 1, that opened the gate to the Russian revolution, justified?

During the closing days of World War 1 in 1918, the evangelistic US President Wilson forced the Kaiser (King) of Germany to abdicate, refusing to negotiate a peace treaty with the Allies otherwise. He wanted to abolish the German monarchy 'with its little secret councils of men' and so to make it impossible for Germany to break out again upon the world with a war of conquest. The Kaiser abdicated on November 9, 1918, 2 days before the Armistice that ended four years of war on French soil. Not even the Socialists in Germany had wanted the monarchy abolished. Nor did the German people blame the Kaiser for precipitating the war, believing they were justified as they were being encircled by the other Powers.

President Wilson's failure to understand this encouraged Germany to conduct a defiant warfare over the terms of the Treaty of Versailles – the occupation of the Rhineland, reparation payments, and disarmament backed by propaganda to make the west believe that the Versailles Treaty had been too harsh – even to the point of bankrupting the country a fate that was aggravated later by the world depression from which Hitler arose out of the ashes to become a new German 'monarch' and fulfil the prophecy of General Ludendorff that 'this evil man will plunge our Reich to into World War 2, as he did.' His war is said to have cost 56,125,262 deaths, while the creation of a European Union to build in the foundations of a League of Nations has now lead to a war of anarchic chaos – the planned World War 3.

Paul Hollnder, in one of his essays, questions why so many clever and very well-educated intellectuals have become pawns of a Soviet KGB socialist culture war in the west? "Has the wholesale disaffection, of so many Western intellectuals, from any sense of allegiance to their own free societies, made a major disruption in all democratic countries? Yes! It began with the French Revolution when all respect for monarchy, law, mercy, or religion was destroyed when King Louis 16<sup>th</sup> was slaughtered. Most changes on offer through the United Nations promoted one universal government created by internet-based fraud in their voting process by anarchistic internet organisations that are

illegal players in the representative voting system. They are one of the worst by-products of the French Revolution.

What is anarchism? Early anarchists promoted the absence of rules. This leads to absence of any identifiable social structure beyond that of personal autonomy. Why is this unacceptable in modern civilized society. When anarchy becomes defined by one anarchist, another anarchist may feel bound to seek to change it. Anarchism thus means different things to different believers as anarchists do not hold common views on subjects such as any desirable levels of community co-operation, or even the role of large industry in society. It blocks continuing debate as to whether anarchy is an end in itself, or the best means to better government. All anarchists think anarchy the best refuge from political dogma and authority.

At first about the 1900's, anarchism shifted its focus to a more general opposition to public and private hierarchy and domination of the working class; and directed their opposition against such pro-capitalist and quasi-government entities as the World Trade Organisation, World Bank and international Monetary Fund. These became the focus of national attention in the late 1900's and early 2000's when they staged massive protests against the World Trade Organisation, the World Bank and the International Monetary Fund in such US cities as Seattle, Washington and , Oregon. Anarchists claim these protests were peaceful until law enforcement officers disputed them. Then these anarchists became violent and unruly revolutionaries.

David Madden founded the internet campaign, Win Back Respect, a website campaign against George Bush first. Then he joined his colleague, Jeremy Heimans in creation of GetUp! In Australia on August 1, 2005 (Age Melbourne) .

**SOS – PARLIAMENTS. Save Our Sovereign Parliaments from Chaos and Get Up!,**  
A growing giant of anarchistic disorganisation in Australian elections.

What is GetUp!? It was modeled on Move On, an organisation aligned with the Democratic Party in America that its foundation organisers, the Australian Harvard graduates, Heimans and Madden, had organised in the US in 2004 backing a 'Clinton for President' campaign using the internet as the primary voting tool. The Fabian Society Secretary in Victoria, internet millionaire, Evan Thornley – together with two leading ALP union 'chiefs' - Bill Shorten (AWU) and Greg Combet – founded GetUp! on August 1, 2005 claiming to unite 'progressives' across the political spectrum. John Hewson, a member of David Rockefeller's Trilateral Commission was also briefly a foundation Leader but left it within weeks. Malcolm Turnbull and Bruce Baird met with them. Andrew Robb, then a Liberal Party 'backbencher' denounced them saying: "The anarchistic GetUp! stands for different things to different believers as anarchists do not hold common views on subjects such as the desirable levels of community co-operation and the role of large industry in society.' Anarchists argue whether anarchy is an end in itself, or the best means to a better government. To all anarchists, though such as those members of GetUp! who vote of single issues not party policy, anarchy is the best refuge from political dogma and authority." Moreover many anarchists agree that anarchism begins with the notion that people are inherently good or perfect, and that

institutions, governments and so forth, limit human potential. (*Legall Dictionary*). A publicity press release on an award to Jeremy Heimans, co-founder of GetUp!, for creating internet vote-promoting organisations. The release claimed “Haemans was a precocious little brat in his native Australia, running media campaigns and lobbying politicians on issues like environmental degradation, nuclear proliferation and global warming from an early age. As an adult Heimans not only co-founded Move On in the US and GetUP! In Australia and Avaaz – the world’s largest web movement with more members than that of all of Australian political parties combined - and an advocacy group in the 2004 Presidential election that raised millions of dollars in ‘small only’ donations for the Clinton presidential election. The press release announced: “The World Government Forum has named Jeremy and Purpose co-founder, David Madden among the Top People who are changing the world of Internet and Politics. His work has been covered in publications like The New York Times (*The Month/ April 1, 2011*).” What price democracy?

The Hon. Bill Shorten MP claimed late last year that his ALP party would have 900,000 GetUp! votes next election (*The Australian September 2015*). GetUp! then had 800,000 ‘members, but expected to reach \$1 million during election year 2016 . The catch is that GetUp! is not a registered Political Party and can only direct voters how to vote, which it does by haunts voting stations during elections urging voters to vote Greens first. A survey in 2006 found 78% of GetUp! ‘members’ are green or ALP voters. GetUp! works by canvassing single issues one by one via e-mail – an unbelievable 75 issues in 10 years, asked whether they agreed or not with any single issue they had received. This system leaves GetUp! open to the risk of being accused of possible fraudulent use of the names of those who do sign. What Greens are justly accused of most by genuine legitimate political parties, is that GetUp! is an active nuisance, advertising and electioneering before, and during, elections as if they are a legitimate political party which they are not. They wear uniforms like the Nazis once did, and harass voters at voting booths with voting priority cards. Worse, they were founded by a \$1.5 million donation from George Soros, the man Thailand called Dracula, who had already left a trail of disaster within 13 countries and is today responsible for the Council of Rome in the city of his birth in Hungary, Budapest. The burning question, that hangs over GetUp! today is whether his Open Society should continue to function here financing civil and university campaigns, and peace movements.

GetUp!’s man, Sheikh, said: “Its impact is visible beyond Australian shores. The American based Aavaz is modelled on it, 38 Degrees.org, launched in the UK was partly inspired by it, and plans are afoot to found it in Canada. At home, various unions and political parties are trying to emulate its campaign techniques. Nearly 1 in 35 voters belong to Getp!, which is an astonishing statistic. Heimans believes the ‘membership’ could reach one million, and Ariadne Vromen, a University of Sydney academics, who studied new forms of political participation, regards the group as “probably our most important civic society actor.” Soros created GetUp! with a fourfold purpose to bankrupt their countries with excessive welfare, to destroy their national character by flooding them with migrants, to corrupt their governments by training ‘left-wingers’ in shadow ‘left-wing’ parties, to form World Government via the UN.

The Club of Rome's final policy is to create a new World of Chaos and to destroy Sovereign Parliamentary government in the process. It grew in the 1960's, and was realised in 1968 in Rome. It described itself as "a global think tank dealing with a variety of international political issues with groups of world citizens who share a common concern for the future of humanity." It consists of current and former heads of state, UN bureaucrats, high-level politicians, government officials, diplomats, scientists and business leaders. During 1970 the Socialist Alliance from the entire world assembled in Paris to lay out its propaganda and education program - the central themes to be followed in publishing, education, science and any relevant institutions that exercise control, or significant influence for 10 years.

Present in the cavernous halls of the giant UNESCO building in Paris, were the perennially intoxicated former West German Chancellor, Willy Brandt, founding chairman of the Socialist International (SI) Olaf Palme ex-Swedish Prime Minister whose mental breakdowns have made medical history, Austrian PM Bruno Kriesky, French Socialist leader Frances Mitterand, one of the world's most influential drug advocates, and the protector of the 'French Connection'. Also there were Jesuit-trained Leopold Senghor Senegal, Greek Society Leader Melina, Auro Peccei the head of the Club of Rome, and the NATO intelligence chief gathered in a *Symposium on Science and Culture* with others of the SI with similar credentials in population policy. Their topic: how to reduce populations under the influence of the SI by 2 billion people by 2000 SI 'policy councils', world-wide over 4 years, had led to the conclusion that plans for population control must now urgently look at more drastic methods than existing birth control. They must now include such expedients as deliberately inducing civil wars, policies to allow famine, policies to lower the immunological resistance of large populations on purpose so as to provoke epidemics, and so forth. Case studies suggest the exact number of child-bearing women, who must be killed in various civil-war scenarios to provide a desired level of population decline in 20 years, is 2,000,000 overall. They concluded the political power of the Socialist International, that was far superior in its political clout, that made them so influential.

**As one declared:**

**"Men are like insects. They proliferate too much. It is an aberration."**

**ETHIOPIA** Ethiopia's Emperor, Haile Sellassie 1892-975, was the last ruler in an unbroken line of eleven hundred and eleven Emperors of a Solomonic Imperial line. He was a benevolent Emperor, ruling over subsidiary kings of his Solomonic descent, who ruled over a largely peaceful and prosperous Coptic Christian country. He established a number of schools, hospitals, banks, airlines and an infrastructure for a modern government. He was the first Emperor to travel abroad, projecting an image of civilisation, power and dignity that impressed all who met him. In 1974 he was forcibly deposed by Russia and China. Colonel Mengistu Mariam led a reign of terror with a gang of 4, backed by guards trained in North Korea by the guards of King Sung of North Korea. Emperor Haile Selassie himself was drugged, killed then thrown down a palace lavatory. Many died in the Torture Centre of Addis Abbaba. 2 million people died in the terrible famine of 1984-5 that followed the massive collectivisation of all private land. Russia withdrew its 5,000 resident KGB officers leaving irreparable ruin and chaos behind them .

**CAMBODIA:** On Pol Pot's return from Paris in 1974, where he had been indoctrinated by communists, he swore to destroy the monarchy as 'a vile pustule' on the body politic. He transformed his tiny guerilla band of 5,000 into an army of 100,000 with money and training from the North Vietnamese communist government. He began to seize control of the countryside, then the capital Phnom Penh on April 17, 1975 while the monarch, Prince Sihanouk, was abroad. A period of total social anarchy and brutality ensued. Its entire 2,000,000 population was forced to leave the city to relocate as peasants in agricultural collectives. They were marched out of the city at gunpoint into what became known as killing fields. Then it began the same policy of annihilation in other cities. In 1976, Pol Pot began 'purifying' Cambodian society of capitalism and western culture for a totally self-sufficient agrarian state - foreigners expelled, embassies closed, currency abolished. Markets, schools, newspaper, religion and private property outlawed. Lon Nol government, public servants, police, military officers, teachers, ethnic Vietnamese, Christian clergy, Muslim Leaders, members of the middle class and educated people were identified and executed. The reign of terror reached a climax in 1978 Pol Pot executed 200,000 of his own cadres. A quarter of Cambodia's 7,000,000 population died in less than 4 years. Prince Sihanouk survived to resume his role in Cambodian society and restore its fortunes.

**MOZAMBIQUE SE Africa:** On Christmas day 1974, when Mozambique ceased to be a colony of Portugal, its Communist National Liberation Front, Frelimo, backed by military from China and the Soviet Union, seized control. Its founder, Eduardo Mondlane, justified this: "With living conditions the way they are in Mozambique, our enemy leaves us no choice." In 1977 declaring the Frelimo Party Mondlane started to nationalise industry and collectivise farms ('villagisation') covering 80% of the population involving a mass emigration of 1,700,000 and an internal displacement of over 3,000,000 against the background of a severe drought and civil war with National Resistance (RENAMO) armed by neighbours-Rhodesia and South Africa costing 1,000,000 dead by 1992. Moreover UNICEF claimed 600,000 died of famine from 1975-85. In 1987 the US Ambassador said a further 3,500,000 were at risk from hunger as more than 25% of massive food aid would be sold on the black market. After the civil war ended in 1990 the Frelimo abandoned Marxism to create a new multi-party constitution. Mozambique turned to the West. It became the only country, not in the British Empire, to join the Commonwealth.

**NIGERIA West Africa:** Two major kingdoms existed in the Nigerian region before the 20<sup>th</sup> century – Benin in the south-west from the 15<sup>th</sup> century to the 19<sup>th</sup> century, and Niri in the south east from the 10<sup>th</sup> century until 1911. The balance in northern and southern regions that existed, when Nigeria became a British protectorate in 1914, was lost when the British plebiscite in 1961 split Cameroon. The south joined the Republic of Cameroon when Nigeria became an independent republic in 1963, a federal representative constitution developed by Britain. After the 1965 election IT Lapsed into 33 years of brutal civil war between rival military juntas marked by corruption, electoral fraud and two notorious bloodbaths of ethnic rivalries. The first began in May 1967 after the Eastern Region declared itself independent as the Republic of Biafra. The response of the Nigerian Western and Northern alliance began a prolonged war by attacking Biafra on July 6, 1967. It committed wholesale murder on a grand scale. A second bloodbath followed the successful coup of General Abacha in 1993, who proved

the most brutal ruler of all, employing violence on a wide scale to suppress unrest. He was found dead in dubious circumstances in 1998. Since then a presidential federation, brokered by the United Kingdom, has liberated Nigeria from the devastation that had proved so ruinous.

**ZIMBABWE:** In 1970, Ian Smith declared Rhodesia a republic, claimed nation status. For the next 8 years of civil war an Smith defended his regime against rival Patriotic Front groups – ZANU led by Robert Mugabe and ZAPU led by Joshua Nkomo. The war ended in 1979 when the Rhodesian governments and Ian Smith's Patriotic Front signed the Lancaster House Agreement. Two months later Mugabe and his ZANU Party won a landslide victory in the election. Two years later he began a compulsory, often violent, redistribution of land from white to black owners in 2000. It caused a shortage of exports, food, capital, currency, expertise in farming, and homes for dispossessed farm hands. Such was the degradation of a once wealthy, thriving country that life expectancy for males dropped from 60 in 1990 to 37, and for females to 34 years. Infantile mortality rose. 1.8 million had HIV. The country had literally gone to wrack and ruin under Mugabe who, in 2008, still refused to concede defeat in the 2008 election, or accept the contempt of the world. for his murderous, vicious megalomaniac regime.
